- **5.0** To enter the competition, you must submit an entry form to Flitwick Town Council by one of the following methods:

 - Completing a form and submitting to Flitwick Town Council, The Rufus Centre Flitwick, MK45 1AH
 - c. Closing date for all entries will be midnight on 6th August 2021.
- **7.0** No purchase by the entrant is required to enter this competition.
- **8.0** Only one entry is permitted per address, per category.

- 13.0 The entries will be put forward to a panel of judges comprising of: -
 - FTC Councillors
 - Flitwick Gardeners Association
 - Flitwick Residents

All above positions will be subject to change at the discretion of FTC if circumstances prevent the above appointed persons being available at the point of the panel conversing on entries. Another member of FTC staff will fill vacant positions. A majority vote will be taken accepted in the event of a split decision.

- **15.0** The Judging panel's decision is final and is not subject to change.
- 16.0 The winner will be notified in writing through the forum in which they submitted their nomination on the 16th August by the FTC Community Team or Communications and Marketing Officer.
- 17.0 The winner will be the owner/tenant address the submission.
- 18.0 The winner will be notified and asked to attend the Flitwick Gardeners Association event at Flitwick Village hall on the 21st August 2021 to receive their award. If the Gardeners Association event is cancelled, then the award day and time may be subject to change.

Creativity – Does the garden. Display use all the available space to its advantage using creative thinking to adapt design and foliage/fauna to the use of space?	10	
Environmental impact – What environmental impact has the garden to wildlife such as use of pollination plants, wild gardens	10
