1. Windmill Road / Chapel Road Parking & Speeding Issues

Cllr Gomm advised that a meeting had been called internally to discuss this area and an update would be available at the next meeting. Cllr Gomm would find out if FTC Members would be able to attend.

2. Froghall Chicanes

Cllr Mackey advised that Froghall Road had now been updated.

3. Water Lane

Highways had advised that the surface was not in a poor enough condition for a resurface. Cllr Mackey was awaiting documentation which included intervention levels.

4. Steppingley 20mph Limit & Cameras

There was a closure in place to carry out carriageway resurfacing. JC advised that speedhumps could be an option for reducing speed.

5. Speeding in Flitwick

Cllr Dodds advised that FTC were currently looking to recruit volunteers to join the speedwatch campaign. Members suggested speed calming measures be incorporated within the plans for the new care facility on Steppingley Road.

JC asked if there was any S106 funding available for Highway works. Cllr Mackey would investigate further.

6. Roundabout Maintenance Licences

7. Froghall Road Railway Bridge Flooding

Cllr Mackey advised that investigatory works were being carried out, no plans to repair the issue had been included on the annual plan for this financial year however it would be added to 2022/23 annual plan if required.

8. Kebab Van - Station Road

ESM advised that she had received no response form the licensing department. Cllr Mackey was dealing with the matter.

9. Cllr Mackey felt that the safer routes to schools should be a priority. JC advised that this could be included within the annual masterplan. JC to circulate masterplan.

Good Morning,

A few months ago, we had an application for Street Trading Consent from Cakes and Canapes. They wanted to trade on Ryder Way, however we received an objection from you on the grounds that the location is a residential area.

The trader has been back in contact to advise that she has been contacted by many residents of the Steppingley Gardens estate asking if she can come to their location. She says that she has spoken to many of the residents face to face, including those who live directly opposite where she would like to park. She also advised that there had been a posting on a local Facebook page 'Steppingley gardens and Froghall Road Resident Group' which also received a lot of support.

I was wondering whether you would be open to her having a trial at the location? She only wants to trade there every other Friday. So maybe a 6 to 8 week trial to see how it goes, with a view to adding the location to her consent if no complaints are received.
