

## Planning Improvement Working Group – Briefing on the planning application for Land South of Steppingley Road, also known as Steppingley Road Field

## What is being planned?

The applicant says that this is for the building of 200 homes on the site. This consists of 120 'market' homes (i.e. homes sold at the market price), 43 socially rented homes, 17 affordable homes, and 20 self-build homes. Supporting this is a variety of works to create open spaces, a new access road onto Steppingley Road, and facilities to support sustainable drainage. This includes the following:

- An open space in the centre of the development
- A green space that acts as an 'attenuation basin' on the north western part of the site (closest to the Rufus Centre)
- A pond in the north west corner of the site

The layout plan is shown below, but can be viewed online by <u>clicking here</u>. The land is currently agricultural land.



## The impact of the development on Flitwick

The Planning Improvement Working Group is still reviewing the supporting documentation for the planning application. This briefing note will be added to over time, and new versions will be published online.

- 3. On the page that comes up, scroll down to where it says 'Application Quick Search' and type the following into the box and then press 'Search': **22/04108**
- 4. On the screen that appears, where it says the application number in the brown box, click on the application number
- 5. On the next screen that appears, click where it says 'View documents (opens in new window)'
- 6. Then, you can browse the case documents at your leisure
