# - Rufus Centre Office Space Refurbishment

Members are asked to consider an application to the RCF for £15,968.53 to refurbish tenant office room 18 and 19 in line with other refurbished offices to include new carpet, a suspended ceiling with LED lights and paint work. This space will also require a new partition wall. Quotation included in supporting papers.

#### - Hinksley Road Play Equipment (UK Shared Prosperity Fund)

# f. Flitwick Footpaths No 13, 14, 22 & Westoning Footpath No 13

Members to consider a response relating to the following consultation from CBC;

Stop up part of Flitwick Footpath No. 13 and to subsequently create a new part of Footpath No. 13 and to divert parts of Flitwick Footpaths No 14, No. 22 and Westoning Footpath No. 13 at Priestley Farm. This will move the footpaths onto the walked routes, resolving a dead end path anomaly and allow the legal lines of Flitwick Footpath No. 22 and Westoning Footpath No. 13 to cross the footbridges.
